I'd like to extend our deep gratitude to everyone who supports and participates in AELA's work – we're very thankful to be working with you! This financial year has been fantastic, for so many reasons. Securing a year of funding support has been nothing short of a dream come true – to be able to earn a living by continuing to grow AELA's Earth-centred systems change work, and to continue to be able to support the work of others, is a gift. This year has been jam-packed with excellent adventures: AELA continued to provide education and awareness raising across more than 100 events and private meetings.

We've been excited to have been approached by several Local Councils, and members of different political parties, to provide advice about Rights of Nature, Ecocide and other Earth-centred concepts and initiatives. We've refined our Earth-centred "Greenprints" program and have started preparing for the practical use and implementation of Greenprints in at least half a dozen communities, with the full 'Greenprints Adventure' starting in early 2023. In July we auspiced and helped host the launch of Indigenous led initiative 'Regenerative Songlines Australia' and continue to collaborate with Future Dreaming, to share Indigenous knowledge about ecological governance, with a wide range of audiences. In addition, my work leading our sister organisation, the New Economy Network Australia (NENA) has enabled AELA and NENA to collaborate to organise our first 'Earth Economics' week, which will be held in September.

The coming financial year is going to be an important one for us – where we begin to delve more deeply into bioregional and place-based Earth centred systems change. Despite the challenges that we all face together – due to our climate changing world, the biodiversity loss crisis and ongoing fight for justice by our Indigenous colleagues – I've never been more excited about the work that AELA is doing with our colleagues and partners.

## AELA's Mission

To increase the understanding and practical implementation of Earth-centred governance in Australia.

## Our Vision

Thriving ecocentric societies, living within their ecological limits and nurturing the living world.

## Our Role

We are a unique think-tank and capacity building organization, providing creative leadership and support to others, to build Earth-centred governance.

## AELA's History and Theory of Change

AELA was created in 2012, by a group of environmental lawyers who were inspired by the theory of Earth jurisprudence. Today, AELA is a multi-disciplinary network working to address the root causes of the ecological crises and continues to be inspired by Earth jurisprudence and the Earth-centred governance of Indigenous Peoples in Australia and around the world.

Earth jurisprudence suggests that we need to recognise that humans are only one part of nature ('one member of the Earth community'), that we are interdependent with the living world, and we need to govern ourselves and our societies, so that we nurture rather than destroy the living world.

### THE PROBLEMS AELA IS WORKING TO ADDRESS

From an Earth jurisprudence perspective, industrialised societies have created the current ecological crisis – a climate changing world, with declining biodiversity and ecological health – due to our human-centred attitudes and actions. These attitudes and actions have led to the creation of systems of governance (including law, economics, education and politics) that see humans as separate from nature, and that treat nature as just human property for endless use and consumption.

## THE NEED FOR NEW GOVERNANCE SYSTEMS

The need for new governance systems has never been greater. To care for our shared home, we need to transition from human-centred to Earth-centred systems of governance, so we can nurture the living world upon which we depend. Despite the indisputable scientific evidence about climate change and environmental decline—and more than four decades of ‘sustainable development’ efforts - Australia’s governance systems have not adapted sufficiently (or at all) to address the root causes of the ecological problems we face, and therefore are unable to make the changes necessary to respond to the current ecological crises.

## AELA’S STRATEGIES AND ACTIVITIES

AELA is committed to building long term systems change, so that human societies can shift from human-centred to Earth-centred governance. We focus on building systems change that will impact on our legal, economic, educational and democratic systems.

AELA carries out its work by supporting multi-disciplinary teams of professionals engaged in research, education, publications, community capacity building and creating new models of Earth centred governance. Our team includes our staff, volunteers and networks of partners and colleagues – including First Nations community leaders, lawyers, economists, scientists, deep ecologists, artists, ethicists and community development practitioners.

## OUTCOMES

Our strategies and programs aim to work across and connect core governance issues in Australia in order to: increase education and awareness about how current governance systems work; create and demonstrate how Earth-centred alternatives can work; and build communities of people inspired by and able to implement Earth-centred governance.

### What is governance?

AELA’s work focuses on how we can shift from governance systems that are human-centred and support endless growth on a finite planet, to governance systems that are Earth-centred, regenerative and nurture all life.

There are many different definitions of ‘governance’.

Within AELA, we use a simple definition: ‘the rules we make to live, work and play together in human society’.

# AELA's Activities in 2021 - 2022

## 1. EDUCATION AND AWARENESS

### 1.1 Provide education and information about ecocentric governance

AELA continues to be Australia's leading organization providing education and raising awareness about the Earth-centred systems change needed to build a successful and just society into the future. Every year, AELA hosts dozens of events – online and in person – to bring Earth-centred ideas and practices to a variety of audiences.

AELA hosted and co-hosted more than 150 public and private events and meetings during the financial year. This included: public lectures, panel discussions, conferences, community workshops and other public gatherings, to provide information and education about ecocentric governance.

This also included more than 40 private meetings hosted by our National Convenor, Dr Michelle Maloney, throughout the year, to provide expert advice about Earth laws to community groups, researchers, political representatives and others. Michelle also worked tirelessly to respond to all requests for interviews and mentoring support.

## Teaching into Universities and Schools

During 2021-2022 AELA’s National Convenor, Dr Michelle Maloney, taught Earth laws into three University Masters Classes at the Australian National University (ANU), University of Queensland and the Queensland University of Technology (QUT). Michelle also joined Future Dreaming, in teaching into two University of New South Wales (UNSW) Masters Courses. Michelle also built on the experiences of early 2021, when she designed Earth-centred governance exercises for a successful school project.

### AELA's work partnering with Future Dreaming Australia



#### Connecting to Place, Caring for Country – workshops co-hosted with Future Dreaming Australia

From August 2021 to May 2022, AELA co-hosted online workshops with our sister organisation, Future Dreaming. These workshops attracted more than 150 participants. Titled 'Connecting to Place, Caring for Country', these workshops featured Indigenous leaders Adjunct Associate Professor Mary Graham (University of Queensland and Kombu-merri and Waka Waka person), Ross Williams, Future Dreaming and Bindal/Juru man, and AELA's National Convenor, Dr Michelle Maloney.



#### Caring for Country – The work of Indigenous Land and Sea Rangers

AELA continued to work closely in partnership with our sister organisation, Future Dreaming Australia, to host online events and hold private meetings with people seeking advice about building cross cultural knowledge about Caring for Country and Earth-centred systems change.

## Regenerative Songlines Australia

Regenerative Songlines Australia is an Indigenous led initiative, working to create continent wide connections, conversations and initiatives that enable people to Care for Country and build regenerative economies and societies. Regenerative Songlines Australia is:

- ◇ led by First Nations peoples and inclusive of all Australians;
- ◇ focused on amplifying local and bioregional initiatives, with a view to maintaining
- ◇ diverse approaches, while strengthening interconnections, mutual learning, and
- ◇ real project collaboration and outcomes;
- ◇ multidisciplinary and includes regenerative economies, societies, ecological
- ◇ stewardship and design practices; and
- ◇ connected to international "regenerative roadmap" partners.

The launch event included Indigenous leaders from around Australia, including **Dr Mary Graham, Dr Anne Poelina, Tyson Yunkaporta, Chels Marshall, Ross Williams, Alana Marsh** and many more. Our National Convenor, **Dr Michelle Maloney** was one of the guest speakers.

In October 2021, Regen Songlines hosted an online event called 'Celebrating our Songlines', which featured **Dr Anne Poelina, Dr Mary Graham, Tyson Yunkaporta** and **Jacinta Tobin**.

Events and activities will be planned each year, to share Indigenous knowledge and promote First Nations' Peoples' regenerative projects and work.





## 1.3 Earth-Centred Economies

### Why AELA Is Committed to Reshaping Our Economic System

Today's dominant economic system is built on the foundations of a global industrial and financial system with immense productive capacity, but the extractive nature of which has created extreme income disparity and social injustice and wrought devastation on the natural world. Earth jurisprudence calls for us to rethink and redesign our legal, economic and political systems, so that they nurture rather than destroy the Earth community. To this end, AELA is committed to supporting the creation of new economic systems and thriving local economies, characterised by small scale, socially just enterprises and community initiatives that nurture the Earth community.

### What AELA Is Doing to Support Economic Systems Change

Throughout "Earth Economies" Program, AELA is working collaboratively with civil society organisations, economists and community advocates in Australia and overseas, to explore and implement innovative, Earth centred economic systems change.

AELA's National Convenor, Dr Michelle Maloney, co-founded the New Economy Network Australia (NENA) in 2016/2017. Since that time she has worked in a voluntary capacity as a Director and Manager to help build the network, which now has thousands of people, organisations and businesses connecting with each other. NENA is a network of individuals and organisations across civil society and Local Government working together on peer-to-peer learning and collaborative projects, in order to transform Australia's economic system so that it serves people and nurtures, rather than destroys, the Earth community.

### This year our work has included:

- ◆ Planning AELA and NENA's first "Economics for the Earth" in September 2022
- ◆ Continuing to support and co-host events with NENA, about ecological and Earth-centred economics
- ◆ Continuing to support and be a member of the Wellbeing Economy Alliance globally, at the international level, and stay connected to other international networks and initiatives such as the Doughnut Economics Action Lab
- ◆ Building a strong economic 'stream' within the Greenprints Program, to support communities on the ground, to explore and reshape local economies

## 2. BUILDING COMMUNITY

### 2.1 Create ecocentric alternatives to current human-centred governance systems

#### 2.1.1 Greenprints – AELA's unique approach to creating Earth-centred governance and systems change

As part of AELA's commitment to creating Earth-centred alternatives to current governance systems, we have spent more than five years researching, developing and piloting a multi-disciplinary, Earth-centred and 'decolonising' systems change framework called "Greenprints".



### Achievements this year

In 2021-2022, AELA hosted a range of information sessions, private presentations and public lectures about Greenprints, which directly reached more than 1,500 people (and is expected to reach even more people via recordings now available on AELA's YouTube Channel).

As part of AELA's promotion of the multi-disciplinary and transdisciplinary work of the Greenprints program, from early 2021 we created and hosted our first 'Greenprints Exchange Workshop Series', featuring experts from a range of disciplines, who shared knowledge and insights relevant to the Greenprints approach. The Greenprints team also continued working with several Local Councils, in private meetings and discussions, to explore how Greenprints might be used within Local Council Strategic Planning processes. A range of other meetings and advisory activities are already planned for 2022-2023.

By mid 2022, AELA began preparing for the practical 'roll out' of the Greenprints across a range of communities in Australia. The 'Greenprints Adventure' will begin in early 2023 and a number of community groups are planning to use the approach in their communities. And we were pleased to be invited to have the Greenprints approach used as the 'scaffolding' for the important work of the Lithgow Transformation Hub over the coming 2 years.

## Working with Greenprints partners

### Martuwarra Fitzroy River Council

In July 2021, AELA's Greenprints Team, Dr Michelle Maloney and James Lee, were invited to Broome (in the Kimberley region) to participate in the Martuwarra Fitzroy River Council's Water Justice Advisory Circle. AELA is working in partnership with community leaders from the Martuwarra Fitzroy River Council (MFRC), and is using the Greenprints program to provide research that supports the Council's goals. The MFRC represents First Peoples of what is now called the Kimberley region.

### Lithgow Transformation Hub

At the end of the financial year, AELA was pleased to be engaged by the Lithgow Transformation Hub, to bring the Greenprints program to the Hub's "Regenerating Lithgow" project, which will run in 2022 and 2023. Regenerating Lithgow is an important capacity building project, that will assist the recovery from the impacts of the bushfires through education, skills building, mentoring and creative activities that will improve interconnected resilience across key areas of the natural, built, economic, and social environment. The Regenerating Lithgow coordinating team is using the Greenprints approach as the 'scaffolding' to connect its various projects, and to bring the entire project into the biophysical capacity of its bioregion.

## Background to the Greenprints Program

'Greenprints' was created by AELA's National Convenor, Dr Michelle Maloney, in early 2016, to help civil society groups and interested government authorities understand, and take very practical steps towards creating, Earth-centred governance. The Greenprints approach has been progressed and piloted by AELA's team between 2016 and 2021, and it fills an important gap, because while we have 'blueprints' to document the design of building and engineering projects, we don't yet have effective 'greenprints' for helping us construct Earth-centred human societies and economies that can nurture the Earth community and live within our ecological limits.

Greenprints provides a practical, step-by-step approach to help people understand both the big picture and the small details, of how to create systems change, transform our societies, and thrive within our ecological limits. It is place-based, encouraging people to start with their bioregions or catchments, and it demystifies and connects the many existing concepts, models and methods that can be used to create sustainable and regenerative communities and organisations.

## Regen Brisbane / Meeanjin

Another exciting element of AELA’s work ‘building community’ is Regen Brisbane.

During the 2021-2022 financial year, AELA auspiced the creation of “Regen Brisbane”. As AELA is based in Brisbane, this ‘Regen Brisbane’ initiative is a way for AELA staff and volunteers to connect with our local place and join the growing movement of people working to generate conversations and initiatives that build a regenerative (rather than extractive) culture, society and economy.

Regen Brisbane was launched at a 2-day event in July 2021, which brought more than 100 people together in a hybrid event. The event demonstrated how the Greenprints approach can be used as a structure to bring different people and ideas together across a region, to explore truly regenerative futures.

In 2022, Regen Brisbane worked with the Queensland Social Enterprise Council (QSEC) to host a series of 4 workshops, exploring Brisbane’s culture, society, ecology and economy. More than 100 people participated via online and in person events. The ideas developed at these workshops will form a foundation for Regen Brisbane’s further community engagement work in 2023, and in particular, will be a stimulus for the facilitation of a “Peoples’ Plan” for the 2032 Olympics.



## 2.1.2 Australian Peoples' Tribunal for Community and Nature's Rights

As part of AELA's commitment to supporting ecological justice and demonstrating alternative governance models, AELA created the Australian Peoples' Tribunal (APT) for Community and Nature's Rights in 2016.

In March 2022, AELA's Australian Earth Laws Centre (AELC) began preparing for the 2023/2024 "Citizens' Inquiry into Australia's Planning Laws". Staff and student interns from the AELC began researching and writing background briefing documents about planning laws in each State and Territory, which will inform the Citizen's Inquiry *Terms of Reference* and Public Hearing process in 2023.

The APT holds Public Inquiries and hears Ecological Justice Cases, brought on behalf of flora, fauna, ecosystems, bioregions and local communities around Australia. As a 'citizens' tribunal' the APT is not a government endorsed activity nor do any of its activities, decisions or recommendations have the force of government-sanctioned law. The APT aims to respond to situations where the current Australian legal system is perceived as failing to support community and nature's rights. The APT provides an educative and culturally transformative forum in which to present a positive, alternative process to address environmental justice and Caring for Country.

The APT Panel is made up of First Nations Peoples, lawyers, community representatives and eminent scientists, hears Inquiries and Cases, and makes recommendations for restorative justice, innovative law reform and socio-political reforms that will Care for Country and protect the Rights of Nature.

## 2.2 Support community groups and organisations to take action

### Australian Earth Laws Centre (AELC)

The Australian Earth Laws Centre (AELC) is the umbrella program for AELA's work exploring and promoting Earth-centred law and regulation – including Earth jurisprudence, Rights of Nature, Ecocide and First Nations Peoples' First Laws. The AELC provides educational opportunities and capacity building support to communities, researchers and others, to help them understand current law and governance, and take action to make systems change.

AELA's National Convenor, Dr Michelle Maloney, participates in conferences, workshops, public talks, reference groups and advisory groups, in order to advocate for Earth centred law and governance. The grant funding AELA received at the beginning of the 2021-2022 financial year also enabled us to employ a part-time lawyer and program manager, Ms Christina Meyers, to support and develop the work of the AELC.

#### **In 2021-2022, the AELC's work included:**

- ◇ Continuing to work with Regen Songlines Australia ([regenerative-songlines.net.au](http://regenerative-songlines.net.au)) and Future Dreaming ([futuresdreaming.org.au](http://futuresdreaming.org.au)), to co-host Indigenous-led knowledge events and projects, aimed at educating Australians about Indigenous First Laws.
- ◇ Supporting the Blue Mountains City Council in the lead up to its announcement in April 2021, that it would adopt Rights of Nature as an operational principle for its work;
- ◇ Hosting three online 'Introduction to Rights of Nature' Workshops throughout the financial year, which involved over 100 participants;
- ◇ Creating the Ecocide Laws Australia (ELA) Working Group – made up of legal experts, law scholars and law students, who are promoting discussion and debate about ecocide laws and developing model laws for Australia. This working group hosted webinars, panel discussions and workshops during the financial year and is planning to draft model laws and host a range of events in 2022/2023.

In May/June 2022, the AELC team also began creating an extensive 'Ecocentric Toolkit' and 'Ecocentric Network' that will be launched in 2023.

## 3. INFLUENCING PUBLIC POLICY IN AUSTRALIA

### 3.1 3.1 Catalyse government and public policy influencers to adopt ecocentric governance

When AELA was first created in 2012, our primary focus was on working with (and within) civil society, to focus on community based education and systems change projects. Over the past three years, AELA has been approached by a growing number of Local Council representatives, members of different political parties and individuals working within government structures, seeking advice about Earth-centred systems change. Consequently, in reviewing our core pillars of work in early 2021, it was decided to create a specific program focus on supporting and educating government and policy makers about Earth-centred systems change. This program is in its early days, but we're excited about the interest that different organisations are showing in Earth laws and Earth-centred systems change.

In the 2021-2022 financial year, Dr Michelle Maloney gave presentations and workshops about Rights of Nature, Earth laws and Greenprints to a range of groups – and AELA continued to give workshops to several Local Councils and several political parties who invited AELA to provide information to inform their policies and approaches.

AELA is planning a series of events and activities for 2022/2023 that are aimed specifically at providing information about Rights of Nature and Earth Laws to Local Councils.

## AELA part of the Blue Mountains City Council Planetary Health Committee

In April 2021, the Blue Mountains City Council adopted the Rights of Nature as an operational principle for its work. Leading up to this decision, during 2020 and 2021, AELA's Dr Michelle Maloney provided support to community members in the Blue Mountains, and later provided workshops to staff in the Blue Mountains City Council about the Rights of Nature. This work led to AELA being invited to join the Blue Mountains City Council Planetary Health Committee and join a number of advisory discussions throughout 2021-2022.

## AELA's Greenprints approach now part of Newcastle City Council strategies

After a range of discussions with innovative thinkers within the Newcastle City Council, AELA's Earth-centred program and framework, "Greenprints" has been adopted and referenced in the Newcastle City Council's "Local Social Strategy". Greenprints was referenced as a "strategy [that] will help our community to thrive while using our resources wisely and not exceeding the capacity of our ecological systems."

Our goal is to contribute to the global discourse and action around ecological justice and Earth-centred governance, and to bring the best new ideas from around the world, into the Australian context.

AELA's Christina Meyers coordinates **Stop Ecocide Australia**, and supports the amazing volunteers who are working to bring the **Stop Ecocide International** campaign to communities, politicians and practitioners in Australia.

## 5. CONTINUING STRONG AELA GOVERNANCE

### 5.1 Ensure strong and effective governance and resourcing for our organisation

2021-2022 saw AELA continue to attract a range of highly skilled professional volunteers, and grow our 'Greenprints Exchange' Experts Network, to build a rich, diverse and highly capable team. We extend our heartfelt thanks to everyone who has shared their time, knowledge, enthusiasm and expertise into the AELA network.

#### **Building a financial base for AELA**

AELA secured grant funding in June 2021 which provided (for the very first time) a part-time income for our National Convenor, as well as two additional part time positions: an Executive Assistant and Program Lead for Greenprints.

In June 2022 AELA was again able to secure grant funding for the work of our National Convenor, and four part time positions, which provided a wonderful opportunity to grow our capacity and our productive output.

#### **Our Background – and why our first grant funding in 2021 is so exciting!**

AELA was created in 2012 by a group of concerned environmental lawyers, with a view to building a professional network for people interested in Earth jurisprudence.

Since that time, under the leadership of Dr Michelle Maloney, AELA has grown into a unique, multi-disciplinary organization focused on growing Earth-centred systems change.

From 2012 to 2021, AELA's Co-Founder and National Convenor, Dr Michelle Maloney worked in a voluntary capacity to build AELA from the ground up. At first this was part-time, but after Michelle survived a gruelling year of cancer treatment in 2015/2016, Michelle devoted her time to building AELA while earning an income from separate but connected work.

To have received funding to continue her work leading and building AELA has been, in Michelle's words "something like a dream come true". We are very grateful and are looking forward to now building upon this initial grant, to grow AELA's financial resources.

# The coming year: 2022-2023

With grant funding supporting our National Convenor and three other part-time positions for 2022-2023, AELA is getting ready for a highly productive year. Some of our plans include:

## **12 July to 30 August 2022 – “Earth Centred Futures” Course (8 weeks)**

In 2022, AELA will be hosting its first, 8-week, multi-disciplinary professional development course, titled: ‘Earth Centred Futures’. With international and Australian guest speakers, covering critically important ecocentric theory and practice, this course is not to be missed.

In the coming year, we’ll be continuing our Greenprints outreach, and developing our support materials, for helping communities engage in the Greenprints Adventure in 2023.

# Treasurer's Report

**Leeanne Leserve**  
**AELA Treasurer**

AELA's FY2022 financial performance, again reflected a strong operational position against the economic uncertainty of the pandemic. With the generous support of our donors, we were able to build and maintain capacity to progress the broad range of work by AELA and develop the Greenprints Initiative. Our focus then was to deliver on our objectives to promote the understanding and practical implementation of Earth-centred law and governance in Australia. For a list of our activities during the year, see page 3 of the Directors' Report.

For the full year, AELA's income was \$192,540 due to \$158,816 donated to support AELA Projects including Greenprints. Expenses increased primarily by payment of consulting and contractor fees, and rent towards establishing a shared workspace called AELA House for the continued research, development and delivery of AELA work including other partnership initiatives. Overall, profit for the year at \$17,170 is comparable to the previous year.

AELA's net assets of \$51,881 included current assets of \$151,881 and unearned income recorded as a current liability. Our cash flow remained robust ending the year with \$159,711 after payment of operating activities.

### Principal Activities

During the year, the principal activities included:

- Hosting and participating in a broad range of conferences, workshops, public lectures, podcasts and webinars, to educate the legal profession and wider community about Earth centred law and governance.
- Developing the Greenprints Initiative, including drafting the Greenprints Handbook, developing MOUs to work on Greenprints in the Kimberley Region, and with Regen Sydney, Regen Brisbane, Regen Perth and Regen Tablelands.
- Continuing to support the development of the New Economy Network Australia; the Ecological Law and Governance Association, the International Wellbeing Economy Alliance and the Australian Hub of the Wellbeing Economy Alliance.
- Progressing the work of the Australian Earth Laws Centre, including working with the Blue Mountains City Council on Rights of Nature and creating an Australian working group exploring what ecocide laws could look like in Australia.
- Continuing to auspice the work and events for sister organisation 'Future Dreaming Australia', a partnership initiative managed by First Nations people and non-indigenous people, to share ecological knowledge and Care for Country.
- Auspicing and supporting 'Regenerative Songlines Australia', an important Indigenous initiative supported by AELA and other non-indigenous allies.

## Objectives

AELA's short-term objective is to promote the understanding and practical implementation of Earth Jurisprudence (Earth centred law and governance) in Australia.

The long-term objective is to see reform of Australian governance systems – including law, economics, education and ethical frameworks - which reflect an earth centred worldview.

## Strategy for achieving objectives

AELA works as a 'think and do' organisation. We aim to achieve our objectives by conducting outreach, education and information activities (workshops, public lectures, conferences, educational courses); conducting and sharing research (including the publication of books, edited collections, journal publications and electronic articles); and partnering with a wide range of other organisations and initiatives, to build networks of people and organisations promoting and implementing Earth centred governance.

## NOTES TO THE FINANCIAL STATEMENTS

### 1. General information and statement of compliance

The general purpose financial statements have been prepared in accordance with the requirements of the Corporations Act 2001, Australian Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board. A statement of compliance with the International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB) cannot be made due to the company applying not-for-profit specific requirements contained in the Australian Accounting Standards.

The Australian Earth Laws Alliance is a Public Company limited by guarantee incorporated and domiciled in Australia. The address of its registered office and principle place of business is 7 Hazlitt Street, Banyo, 4014.

The financial statements for the year ended 30 June 2022 were approved and authorised for issue by the Board of Directors on 19 August 2022.

### 2. New, revised or amending accounting policies

*AASB 1058 Income for Not-for-Profit Entities* and *AASB 15 Revenue from Contracts with Customers*. AASB 1058 clarifies and simplifies income recognition, in conjunction with AASB 15. These standards shift the focus from a reciprocal/non-reciprocal basis to a basis of assessment that considers the enforceability of a contract and the specificity of performance obligations.

AASB 1058 applies when a NFP entity enters into transactions where the consideration to acquire an asset is significantly less than fair value of the asset principally to enable the entity to further its objectives; the excess of the asset recognised (at fair value) over any 'related amount' is recognised as income immediately.

Under AASB 15, an entity recognises revenue when (or as) a performance obligation is satisfied. This occurs when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer.

These new standards are not applicable for the reporting entity but are relevant for an annual reporting period beginning on or after 1 July 2019.

Accounting standards issued but not yet effective have not been adopted.

### 3. Summary of accounting policies

The financial statements have been prepared using the measurement bases specified by Australian Accounting Standards for each type of asset, liability, income and expense. These measurement bases are more fully described below:

### **3.1 Revenue**

Revenue includes conferences and workshops, fundraising activities, and member contributions. It is recognised when the amount can be measured reliably, collection is probable, the costs incurred or to be incurred can be reliably measured. Revenue is measured by reference to the fair value of consideration received or receivable.

### **3.2 Donations and fundraising**

Donations and fundraising are collected and recognised when the reporting entity gains control, economic benefits are probable and the amount of the donation can be measured reliably. This is limited to amounts banked and recorded in the bank accounts.

### **3.3 Operating expenses**

Operating expenses are recognised in the accounting records at the date of their origin.

### **3.4 Income tax**

There is no provision for income tax as the company is exempt under Division 50 of the *Income Tax Assessment Act 1997*.

### **3.5 Cash and cash equivalents**

Cash and cash equivalents include cash on hand and demand deposits, together with other short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

### **3.6 Economic dependence**

AELA is dependent upon the ongoing receipt of community and member donations, and ongoing income from events and webinars to ensure ongoing continuance of its programs. At the date of this report, the Directors' have no reason to believe that this financial support will not continue.

### **3.7 Significant management judgement in applying accounting policies**

When preparing the financial statements, management undertakes a number of judgements, estimates and assumptions about the recognition and measurement of assets, liabilities, income and expenses.

### **3.8 Events after the reporting period**

No adjusting or significant non-adjusting events have occurred between the reporting date and the date of authorisation.
